Julie was homeschooled and received her Bachelors of English Literature and Biology from the University of Toledo. Later she received her Masters of Clinical Nurse Leadership from the University of Toledo.

Julie was the beloved wife of George Anthony Roth, III (Tony). She was a devoted mother to her two children, George Anthony IV "Rory" and Ayla Lily, and was looking forward to their third child due this spring. Julie and Tony met as adolescents while taking a homeschooling Spanish class. They met again as adults at Fed Ex and their first date was making chocolates. They married in June of 2015. They enjoyed competing in Tough Mudder competitions and was looking forward to traveling. They had many hopes and dreams for their growing family

Julie was also a dedicated daughter, sister, aunt, niece, cousin and friend. Our family is devastated by her loss. treats for others to enjoy. She was a creative mind that loved painting and was in the process of writing her first novel. She was also an avid gardener.
